Embedded videos, learners can access the videos by scanning the AR codes on the printed Study Guides using the Zappar application from the Play Store (Android phones) or the App-Store (Apple Phones). You can also access the same videos embedded in the online course topics.

User ID and Access Codes will be forwarded to learners 3 days before sessions commence via emails from SunwayTES together with instructions on how to access the eLearning System

Please take note that the **online content for Chapters** are released based on weekly schedules. Learners are also required to complete the topics progressively. The course content are programmed to be released adaptively, that is after each topic has been activated. The topics cannot be accessed randomly.
